- b. Support for City of Eau Claire Housing Ordinance
 - This is a revision to the long standing City Housing code
 - The health department is interested in supporting healthy and safe housing and hope that this ordinance will reach the county level
 - There was a large public meeting at the public library where community members could express their questions or concerns
 - Community feedback has been largely positive although the department is tracking concerns and questions. These include issues related to fees, registration process, and other items.
 - Board members express that the pictures from the PowerPoint really speak to the importance and value of the ordinance update

- There are approximately 12,600 units (rental) and 27,000 dwelling units in the city
- Our goal is that once we have a better more proactive approach there will be fewer complaint based inspections.
- Currently there was no incentive to maintain properties, this ordinance revision changes that
- Hoarding is often very complex and a hoarding task force is assigned to those situations
- If CDBG grant funding changes it would impact how much work can be done
- The program is tailored to fit requirements in WI Act 176
- The inspection criteria would still apply if transferred to a new owner. It wouldn't prohibit the sale, but the new owner would ultimately be responsible for necessary repairs
- There are some proposed changes that will be added to the draft ordinance before it is presented at City Council. These are based on stakeholder input.
- A board member is asked to be present at the City Council meeting on April 24th for public testimony. Board members are asked to let Merey Price know if they are interested
- Board members discussed opportunity to move toward an incentive based approach rather than just responding/reacting to problems

 - This is a relative ranking
 - Some areas of concern for Eau Claire County include excessive alcohol, income inequality, and severe housing problems. This is a strong reinforcement of the importance of the work that the Health Department is doing
 - Rankings information is shared with community partners and the media.

 - Board members ask that after health department staff has analyzed it bring it back for discussion
