### Chippewa and Eau Claire Counties Identify Top Community Health Concerns

**Eau Claire, WI – June 18, 2018** - The 2018 Community Health Assessment Planning Partnership Committee is releasing the top health concerns in both Chippewa and Eau Claire Counties. The top health concerns are identified through the community health assessment. This is a year-long process involving county health departments, local health care facilities, nonprofit organizations and community members.

The assessment helps the community prioritize the top health concerns in the county and working towards health improvement. As a result of the assessment process, partners can work together on initiatives that align with the newly identified health concerns.

The assessment includes information about how data was collected and used to determine the health concerns in the community. Both counties identified **alcohol misuse**, **mental health**, and **substance use** as the top health concerns.

#### Top Health Concerns

1. Alcohol Misuse
2. Mental Health
3. Substance Use

“The partnership could not have completed the assessment process without the active engagement and commitment of the community.
