In partnership with the six law enforcement agencies in Eau Claire County, the Eau Claire City-County Health Department and (for tobacco checks) Wisconsin Wins, compliance checks are collaboratively conducted countywide on an ongoing basis. A letter from the Health Department is sent annually to all license holders to remind them of these ongoing investigations.

About Wisconsin Wins

The Eau Claire City-County Health Department contracts with the Wisconsin Department of Health Services to conduct investigations through the Wisconsin Wins Program. The Wisconsin Wins (WI Wins) campaign is a science-based, state-level initiative designed to decrease youth access to tobacco products.
